EP updates

The 2022/23 was another busy year for the EPS and this seems to reflect the national picture. At the end of June, the government published an Educational Psychologist Workforce Report, highlighting some of the struggles being faced by EP Services nationally. We are fortunate in RBG that, despite the pressures, there has been significant investment in our EPS. Last academic year we welcomed 6 new EPs, 2 Assistant EPs and 2 EPs in Training (EPiTs). As of September, we have completed a re-organisation which will see the Outreach Counselling and Restorative Approaches Services expand and join the EPS. There will be additional admin support for all teams, and an increase in senior and specialist senior EPs. We are also pleased to have a further 2 EPs and 2 EPiTs who have joined us this year and we will continuing to be working with Sanctuary Personnel (locum agency) to respond to the statutory demands.

Our growing team has enabled us to carry out a range of interesting, varied and impactful work in schools and settings, and we look forward to this continuing. Please see our <u>Direct Services</u> webpage for more information about how you can work with your EP to maximise impact, we have also updated our service specification which we hope will provide a useful overview of what we offer.

We anticipate that 2023/24 will continue to feel very busy for us. In July alone, we have received over 70 requests for EHC needs assessments – a record number! The need to respond to these requests does limit our capacity in other areas, and we would therefore like to take this opportunity to share some information and reminders for school leaders/SENCos as we start the new term about common requests or gueries that we receive:

EP 'reports' and requests for EHC needs assessment and admission panel requests: The EPS uses a consultation model of service delivery and work is recorded in the format of 'school visit records' rather than reports. When applying for EHC needs assessments, schools are asked to provide evidence of professional input over time (including how they have involved the EP). EP input contributes to the assess-plan-do-review process (with school taking responsibility for implementing a graduated approach) and this can be evidenced in a number of ways. This may be through the EP visit record, through the narrative provided in the EHC needs assessment profile completed by school (providing a clear account of how they have involved the EP over time, what has been put in place as a result and what the impact has been) or, for example, through multi-agency records (such as TAC meeting minutes). When a needs request is received by SEND, contact is made with the EPS and they are asked to provide any records that they have, but an EP report is not needed to evidence EP involvement. EP representatives also sit on the Needs Assessment and Admission panels, and this can be one of various ways in which EP input can be shared.

Re-assessment requests: We often receive queries relating to EP assessments of children with EHCPs whose plans might need updating. Unless EP involvement is requested by the RBG SEN department, schools will need to request this work within their traded EP time. We have found it works well for the EP to carry out assessment or observations in advance of the annual review so that their input contributes to co-construction of new outcomes and/or updates to provision during the annual review meeting. Any work undertaken from the schools traded time (or by a commissioned EP service for schools who do not buy-in from the RBG EPS), will not be reimbursed and should be covered by the funding associated with the child or young person's EHCP.



Specific situations in which SEND might request a re-assessment include:

- -Following formal parental request for a statutory re-assessment. This will be considered by the LA who will decide whether to proceed with the request. The LA does not have to reassess if it has carried out an assessment within the previous six months or if it considers that a further assessment is not necessary. It should be noted that, when a re-assessment is agreed, this will follow the statutory timeframe of a new needs assessment and will return to na2 panel once updated advice has been received. Usually, a more effective way of updating the EHCP is to request for amendments following the annual review (As described above).
- -As part of the tribunal process or following mediation.
- -When a child or young person is not in school.
- -If a child or young person is new to the LA and updated information is needed for the production/ adoption of their EHCP.
- When a request is made to cease a child or young person's plan and there is a lack of agreement between school, parents and/or the child or young person regarding this course of action.

We look forward to working with you all in the year ahead and continuing to do all we can to support the children, young people and families in Greenwich!



Our next ELSA training cohort is due to start on 18th September 2023. We have been in receipt of Public Health Grant funding so can offer places to RBG schools for a subsidised rate of £100. This covers the 6-days training and supervision for this academic year. We still have a few spaces available, to be offered on a first come first served basis. SEND ASSESSMENT AND REVIEW SERVICE UPDATE

Following the SEND Area Inspection there will be a focus on not only attending annual reviews at phase transfer and updating EHC Plans accordingly, but increasing the number of EHC Plans that are issued within 20 weeks. A review of the service identified:

- -That our team of dedicated Needs Assessment officers ensured we vastly improved our compliancy rates, with more Education, Health and Care (EHC) Plans issued within 20 weeks. However, requests for EHCNAs continue to increase and the optimum number of new referrals for individual officers has been exceeded, with each officer managing in excess of 50 new referrals at any one time.
- -The AR team was in the main a new team of officers who were equally split to focus on 0–13 year olds and 14-25 year olds in order to secure our preparation for adulthood arrangements. This model had resulted in significant fluctuations to working patterns due the phase transfer of certain groups and the requirement to attend those annual reviews. At times it has not been possible to manage these fluctuating demands and ad hoc arrangements have had to be put into place.

Given these findings we are reverting to an all through service where an allocated officer for each school will be responsible for both EHCNAs and Annual Reviews, building and maintaining relations with both parents, children and schools in order to improved continuity and the quality of the service delivered.

Officer allocations

You will be receiving correspondence from Team Leaders and individual officers in the coming days, introducing themselves and arranging an initial meeting to discuss your SEND cohort. Team leaders and senior officers will also be attending the first SENCO Network meeting of the year on Thursday 12 October 2023.

Priorities

Our aims as ever are to provide a timely, responsive and quality service to children, young people, parents and schools. We hope the new ways of working and the addition of new officers will further enable us to meet the ever-growing demand across the LA.

Our focus this year is on improving our Annual Review processes; enabling more officers to attend Annual Reviews at phase transfer points. There will also be a gradual year on year increase to the number of EHC Plans we are updating following phase transfer Annual Reviews to ensure children and young people are well supported as they move into the next stage of their education.

Together with Inclusion and Attendance Advisory services, we are also asking officers to take a proactive role in monitoring the use of part time timetables. Officers will be asking you for updates with regards to YP with EHCPs being educated part time.

Panels

As always SENCo input to both the NAI and NA2 panels are invaluable and critical to ensuring a schools perspective. We are asking SENCOs to commit to attending one of each of these panels per academic year. We have attached the schedule for this year and ask that you encourage and support your SENCos to attend.

We look forward to seeing SENCos at the Network meeting on Thursday 12 October.

It includes:


- An Access Arrangements Timeline to help SENCOs navigate AA across the year.

- a **Data Protection Notice** for students to sign.


Two other forms have also been introduced this year:

ASD OUTREACH REFERRALS: IMPORTANT REMINDER

This is reminder from past emails about how to refer to the ASD Outreach service. We will be sending referrals back to you if they are not completed as below from now.

The new processes are to ensure that new referrals to our service are seen promptly with all the right information available. We had sent out School information gathering Sheets which need to be completed by schools BEFORE any new referrals are seen. Ant delay will also delay referrals being seen even of we have all the parental and diagnostic information.

Because of the high level of demands on our advisory teachers, and the time taken to chase up these forms when they are not sent in early, we will not be allocating the cases until our office receives the information forms.

ASD Outreach and EP training about EBSA

Last academic year, in response to awareness of increasing need members of the ASD Outreach Service (ASDOS) and Educational Psychology Service (EPS) collaborated to develop a course focusing on Emotionally Based School Avoidance (EBSA) and ASD.

During the summer term the course was piloted, with other members of the ASDOS and EPS offering feedback. The course content has been updated and will be running on three dates (one per term) for a full day in the PDC. This course is designed to offer participants an understanding of factors underpinning EBSA together with why autistic children and young people might be at particular risk and is appropriate for anybody who is involved in supporting children and young people who experience EBSA. It includes the sharing of theoretical information together with discussion and hands-on activities.

The course explores evidence-based approaches and interventions in relation to EBSA and how these can be used with a range of children and young people, including those who are autistic.

Proposed dates are: 06/11/2023, 26/02/2024 and 10/06/2024 (09:00 – 16:30) – although these dates are yet to be confirmed. Further information will be in the PDC training brochure – and so keep an eye out!

- Introduce all the SEN processes re statutory requests. Annual reviews and SEN support
- Ensure you are familiar with any systems and processes we have here e.g re part time timetables etc..
- Introduce you to key SEN officers
- Discuss person centred planning

Sessions are quite informal with a mix of structured tasks, presentations and discussions and will take place after the October half term. We will be sending emails individually to staff we know have changed but all are free to book,. The course is free of charge and will take place at the SEND Outreach Services base in Eltham. Please do book though on the PDC website so we know who is coming and to find out the dates and timings.

IMPORTANT INFORMATION Deadline for Y6 Dyslexia referrals

This is a polite reminder that whilst we are continuing to receive high volumes of referrals, please can we request that all Year 6 referrals are received **no later than the end of September each year**, to allow us sufficient time to assess pupils, before they transition to secondary school.

We have had a number of very upset parents contact our service to request an assessment after returning a referral that has been received after the September deadline, creating quite difficult situations to manage.

We would always recommend that pupils are referred as soon as possible for a dyslexia assessment, preferably before they leave Y5 if they have been attending school regularly, had targeted support/intervention and they are not making the expected progress in literacy (and there are no other underlying difficulties impacting on their learning).

Please note that if a child is new to your school having entered in upper Key Stage 2, we will do our utmost to ensure that an assessment is carried out.

BACKGROUND






- Joint working across the SEND system

Solution Circles



With the support of staff at Heronsgate Primary School, Minna (ASD Outreach Service Teacher) and Kirsty (Educational Psychologist) have developed a webinar which shows how solution circles can be used to tackle problems. The insights and solutions webinar provides quidance on how to implement solution circles as a framework for solution-focused problem solving. The solution circle framework supports school staff in exploring relevant issues or problems as a group. The framework ensures that you do not get 'stuck' in the problem but collectively generate practical and realistic solutions. The underlying premise of the approach is that collectively we can generate more sustainable solutions than when problem solving in isolation. The resources included as part of the webinar should be explored and utilized when implementing this approach. Our <u>managed move guidance</u> is aimed at supporting schools with this process and ensure that every child who is being considered for a managed move has the best opportunity to succeed.

We want to give schools an opportunity to discuss this process and ensure there is full engagement from all parties when agreeing a managed move.

ePFPs

Over the last academic year, officers in the Virtual School have been reviewing our PEP forms and decided to move to facilitating ePEPs for all our children in care. We hope this will support schools and social workers complete the statutory paperwork more easily and help communicate the support to the network of professionals around our children. We aim to launch ePEPs from January 2024.

Training for this will take place at the PDC on Tuesday 28th and Wednesday 29th November 2023 for Designated Teachers (DT). We have arranged four training sessions across these two days to provide all DTs with the opportunity to attend. The training is free of charge and bookings can be made by using the link below:

Previously Looked after children (PLAC)

In 2014, the government recognised that many care-experienced children and young people that have now been placed via an Adoption Order, Special Guardianship Order, Residency Order or Care Order away from their birth parents, were still experiencing trauma and needed financial support.

From September 2023, every child adopted from care in England and Wales is eligible to a grant of £2,530 per annum through Pupil Premium Plus which is paid directly by the government to your school. To receive the Pupil Premium Plus grant, a child or young person must be registered on the **October 2023** census. If they have not been registered, the funding will not be forthcoming from the DfE until the following year. Your school should be aware of the adoptive status of children and have sight of the relevant documents (redacted if preferred by the parent) in advance of the October census.
